

**PROCEEDINGS OF THE SELECTION COMMITTEE MEETING FOR ENGAGEMENT OF
STAFF NURSE UNDER NRHM IN ANGUL DISTRICT**

As per instruction, given by Mission Director, NRHM, Orissa and approval of Collector, Angul the following members of Selection committee were present and verified the original certificates under the Chairmanship of Chief District Medical Officer, Angul.

1. Chief District Medical Officer, Angul
2. District Development Officer, Angul
3. Asst. District Medical Officer, (FW), Angul
4. Sub-Divisional Medical Officer, Angul
5. District Programme Manager, NRHM, Angul

There are 68 Nos. of candidates attended the walk – in – interview for the post of Staff Nurse (Annexure – 1), out of which 62 Nos. of candidates have passed the required GNM Training and obtained their Registration Number & Residence certificates whose documents were verified by the selection committee. (Annexure – 2).

A merit list of candidates belongs to Angul district has been prepared by the selection committee (Annexure-3). As per ORV Act, it was found that all the 6 Nos. of candidates from Angul District shifted to UR category out of 7 Nos. of candidates due to 6 Nos. of sanctioned posts in the UR category. Selection committee prepares a statement containing the detail merit list of candidates (category wise) belongs to Angul district (Annexure – 4).

The selection committee prepared a merit list of candidates belongs to Other district (Annexure-5) a statement containing the detail merit list of candidates (category wise) belongs to other district (Annexure – 6).

Finally a statement showing the list of candidates has been prepared by the committee who should be appointed as Staff Nurse under NRHM according to the ORV Act and the rest candidates are in the waiting list. The place of posting of Staff Nurse will be made by CDMO concerned as per requirement of the Health Institutions.




