Police Modernisation:-

Now the District is having 22 PSs with 4 SDPOs, Office, One Office of DIGP (NCR) at Talcher. The Office of DIGP opened at Talcher on 14.03.05 to control & prevent crime & criminals/ L&O in three districts namely:-1. Angul, 2. Dhenkanal & Deogarh.

Out of 22 PSs, 13 PSs having been provided with computer system under CIPA/CCTNS Project. The rest of the PSs are under process. All the SDPOs provided computer as well internet connection including Office of the S.P., at Headquarters. Thu there is no Mahila PS in the district all the PSs provided with lady police officers/Constables under Mahila and Sishu Desk to redress the difficulty of Sishu & Mahila reporters.
