

**PROCEEDING OF DISTRICT VIGILANCE MONITORING COMMITTEE MEETING HELD**  
**ON 2<sup>nd</sup> FEBRUARY '2011**

The District vigilance Monitoring Committee Meeting was held on 2<sup>nd</sup> February 2011 under the chairmanship of S.J. Tathagat Satpathy Hon'ble MP Dhenkanal in the conference hall of DRDA Angul. Members present in the meeting is in Annexure-A.

At the outset Collector welcomed the chairman, Co-Chairman and all the members of the committee. Chairman also accorded warm welcome to the members present in the meeting.

Chairman expressed that more emphasis should be given to vigilance than monitoring at block level. The Projects should be implemented in time otherwise there will be cost exhalations and the projects should not be withheld due to interference of external force.

Chairman instructed for completion of Bharat Nirman Rajiv Gandhi Seva Kendra at block level & GP level with in three months i.e before the next DVMC meeting.

Co-Chairman expressed his displeasure on excavation of a new pond under MGNREGS over a public road and steps have not taken for construction of this road as the same has been intimated in the last DVMC meeting. Chairman instructed BDO, Athamallik to complete the road in all respect as usable by the mid day of 28<sup>th</sup> February under intimation to the Chairman, DVMC & Collector.

Again he expressed that the job cards of Job seekers under MGNREGS found with the contractors in place of job seekers so the real objective of MGNREGS is not fulfilled. Discussing on this Collector intimated that action will be initiated against the official responsible for this if this type of cases come to the notice.

Co-Chairman expressed his displeasure on non payment of IAY instalments to Sri Antaryami Sahoo of Bhagatpur village of Tainsi GP, Discussing on this Chairman instructed PD, DRDA and BDO, Angul to jointly enquiry on this and take appropriate steps with in four days.

Discussing on misappropriation of IAY fund in Luhasinga GP, Collector instructed PD, DRDA to put the draft charge received from BDO, Athamallik early.

MLA, Talcher instructed to issue further reminder and inform Govt. in PR Deptt over telephone on payment of further instalments to IAY beneficiaries of Kalamchhuin village of Talcher block.

Chairman expressed about non completion of Fullpada -Talamula & Angarabandha-Khandahata PMGSY roads and instructed Executive Engineer (RWD), Angul for early completion of these roads and again he wanted to visit the roads with EE(RD), Angul and BDO, Banrapal.

Discussing on the completion of PMGSY roads, Collector instructed E.E.(RWD), Angul to furnish list of complete projects to Hon,ble MPs & MLAs for inauguration. Chairman expressed that as those projects have been constructed with Govt. of India fund and after visit to those projects they can appraise Govt. of India on the quality of roads constructed out of PMGSY.

Regarding completion of Kamarai road, MLA, Talcher expressed his displeasure for non completion of the road after a long period. Collector instructed EE,(RD), Angul to sought a clarification from Govt. regarding completion of this road with the balance fund of Rs. 8 lakhs.

Chairman suggested for to take up this road out of NTPC periphery fund and issue a letter to NTPC Authority in this regard.

Lastly discussing on work of Angul Rural Development Division , Hon,ble Chairman expressed that the work taken by Angul RD Division are not transparent and the DVMC expressed displeasure on the performance of the Division and advised Collector, Angul to inform Secretary ( RD) to take step and request Govt. to rectify the anomaly of the Department.

Discussing on the shortage of Drinking water supply at Bauligarh G.P under Banarpal Block, Executive Engineer (RWSS), ~~and~~ Talcher intimated that steps are being taken for excavation of intake well / percolation well to meet the demand during summer. Chairman suggested to take up water harvesting structure or check dams to recharge the ground water in this area. Agian he instructed BDO, Banarpal to take up Farm ponds under MGNREGS at Bauligarh.

Chairman expressed that the PWS at Tikarapada is not functioning properly and instructed E.E. (RWSS), Talcher to take steps for early functioning of this project.

Regarding misappropriation of NRHM fund Chairman instructed the CDMO, Angul to withdraw the case from police and hand over to vigilance immediately.


Nominee of Hon,ble Chief Whip, informed the house that all projects of Nagira GP of Pallahara blocks should be enquired by Dist. Authority.
